Applications are invited from interested persons to serve in the Departmental Audit Committee.

The Audit Committee will consist of a Chairperson and so many members as determined by the Department to ensure the independency of the Committee.

In terms of Treasury Regulation 3.1.10, the functions of the Audit Committee are, among other, to review the following:

- (a) The effectiveness of the internal control systems;
- (b) The effectiveness of the IA function;
- (c) The risk areas of the institution's operations to be covered in the scope of internal and external audits;
- (d) The adequacy, reliability and accuracy of the financial information provided to management and other users of such information;
- (e) Any accounting and auditing concerns identified as a result of internal and external audits;
- (f) The institution's compliance with legal and regulatory provisions; and
- (g) The activities of the IA function, including its annual work program, coordination with the external auditors, the reports of significant investigations and the responses of management to specific recommendations.

Applicants must comply with the following requirements:

- (a) Preference will be given to persons with knowledge and experience in relation to the activities of the Department Local Government and Housing.
- (b) Preferable be a member of the Accounting professional registered as such in terms of the Public Account's and Auditor's Act.
- (c) The Chairperson must be independent, knowledgeable of the status of the position, has the requisite business, financial and leadership skills and may not be a political office bearer.
- (d) Persons applying to serve on the Audit Committee must be permanent residents in the Free State Province.

Members of an audit committee who have been appointed from outside the public service pursuant to section 77(a)(i) of the Public Finance Management Act, Act no. 1 of 1999 as amended must have appropriate experience, be appointed on contract and be remunerated in accordance with paragraph 20.2.2 of the Treasury Regulations.

Applications should be accompanied by a comprehensive curriculum vitae clearly indicating relevant experience.

The closing date for the applications is 24 February 2006, 11H00 and should be submitted in a sealed envelope in the Departmental Tender Box, situated on the 7th Floor Foyer, Lebohang Building Bloemfontein.
